Reading of the Minutes

There was no regular KetMorDet meeting during November as Members celebrated the Marine Birthday Ball instead. In addition there also was no Newsletter in November. The December Newsletter was printed later than usual and not all of the Members had the opportunity to see the October Minutes in it. Discussion of both the October and December Minutes will be held during the regular January Meeting.

Paymaster's Report

The Paymaster distributed the Financial Report. He felt the 2007 Marine Birthday Ball was a huge success with 59 paid attendees. This was agreed upon by those that attended it. The Ball came in **UNDER** budget again this year. Ted Conde gave the Paymaster a \$50 refund from the security deposit for the Birthday Ball hall rental. There is a CD that will mature at the end of December. Paul Bollmann made a motion to let the Paymaster automatically renew CD's as they come due. The Paymaster and Adjutant Jason Waier said that it only takes a minute to mention the CD's when they are due and someone may know of better interest rate then at different banking institutions. There was no second to the motion. Fritz Montag made a motion to accept the Paymaster's Report. Motion seconded by Don Erdman and passed. The Paymaster has received solicitations from "The Museum of the Marine" in Jacksonville, NC and "The National League of Families of American and Missing in South East Asia". There was no positive feedback to donate at this time to these organizations and the matter was dropped. Donations are being sought for "The Fountain of Tears", a Korean War monument which is being built at The High Ground Veterans Memorial Park. Jim Krudwig made a motion to get more info on purchasing a Legacy Stone which would be placed in The High Ground's plaza walkway. You can visit their website at www.thehighground.org. Motion seconded by Paul Bollmann and carried. The Paymaster has the winter Detachment jackets on hand for Members to purchase. The cost is \$58. If interested contact Roger Cross.

Chaplain's Report

George Wujcik was at the December Meeting and is recovering from recent surgery. Jim Krudwig said that Doug Duffin has not been able to participate in recent Det. activities due to his health. The Chaplain said that he has spoken to Cal Racine and that he is back to work after his surgery.

Correspondence Received/Delivered

During the October Meeting John Fleischman stated that Rush Limbaugh had made a huge donation to the Marine Corps Law Enforcement Foundation. The donation came from the sale of a letter written by Sen. Harry Reid and signed by 40 other fellow Democratic Senators. Mr. Limbaugh had made a comment during his radio program pertaining to "phony soldiers". He was talking about all the people falsely posing as military veterans, who are being brought to justice. Harry Reid twisted the meaning of those comments to include ALL veterans, not just those posing as veterans. He wrote a letter to the CEO of Clear Channel Radio, who hosts the Rush Limbaugh radio show, asking him to publicly repudiate Mr. Limbaugh, and make him apologize for his comments. Not only did Mr. Limbaugh not apologize for his comments, he put the letter up for sale on e-bay. He stated he would match the amount that the letter sells for with the proceeds to go to the Marine Corps Law Enforcement Foundation. The letter sold for \$2.1 million dollars. Rush Limbaugh kept his word and matched that amount. There are several good articles on the internet pertaining to this. Just GOOGLE "Rush Limbaugh smear letter" and everything from a copy of the original letter, to a video of Harry Reid on the Senate floor talking about it. Dan Coulter noted that the general public may not appreciate finding out that the money they had donated was used for Detachment parties. Jim Krudwig said that any potential problem could be alleviated if consideration would be given to using specific fundraisers like Brat Fry proceeds for Detachment activities versus Marine Rose proceeds used for the troops and other charities. Roger Cross is already working on scheduling 2008 Birthday Ball guest speaker. Paul Bollmann made a motion to present a thank you card and plaque to the 2007 Ball guest speaker, LtCol Gillette, for his outstanding presentation. Seconded by Paul Link and passed.

Old Business

Ted Conde spoke about the new Freedom Memorial in front of the Old County Courthouse Museum Plaza in West Bend. It will be a new monument for veterans of the War in Iraq. It will be placed near the WWI Doughboy statue which was erected in 1927, and the WWII, Korean, and Vietnam War monument which was erected in 1998. During the rebuilding of the Plaza, KetMorDet could purchase an 18x18 inch granite stone with the Detachments name on it to help defer the cost of the new monument. Jim Krudwig made a motion to purchase one stone for \$150 with it saying Marine Corps League, Kettle Moraine Detachment #1203, Washington County. Roger Cross stated he would talk to Wally Miller of Miller Monuments to see if it could all fit. Motion seconded by Paul Bollmann and passed. As noted in the last Newsletter Carl Heiman has found a website where the black double soled dress shoes can be purchased on line for \$26.97. These are seconds, or blemished shoes, but can be found at www.sportsmansguide.com. Both Paul Bollmann and Jim Krudwig stated that all Members need to participate in more Det. events. There are currently 53 members, but only a small percentage do most of the work. It takes team work to get the job done.

New Business

Nominations will be taken at the January Meeting for the 2008 Detachment Officers. Elections will be held at the February Meeting. The Adjutant is working to arrange the Dept of WI State Commandant to swear in the new Officers at the March Meeting. The Judge Advocate has served the two year maximum permitted by the Det. By-laws, and the Sr Vice Commandant, and Sergeant at Arms are not seeking re-election. Members are asked to step forward to help lead the Detachment for the next year. We cannot operate without leaders. Nominations will be taken for ALL Officer positions. Duties of the Officers can be found by clicking on the Calendar/Forms tab of the Detachment website www.ketmordet.com and then clicking on the Detachment By-laws on the right column. Jim Krudwig said that the short sleeve summer shirts are not appropriate for winter wear and spoke of looking into purchasing long sleeve shirts, ties and tie clasps for the Color/Honor Guard and Flag History Presentation team. The cost would be around \$75-\$80 each when finished. The total cost should not exceed \$1500 to \$2000. The donations being received for the many FHP's should eventually cover this cost. Most of the FHP's are conducted during the winter season. Paul Bollmann made a motion that this be considered. Don Erdman seconded and passed. Jim Krudwig stated he would write up a proposal and present it at the January meeting.

Paul Bollmann brought in coffee and donuts for the Members. Come in early for the meeting and share some time with your fellow Marines. Instead of just showing up once a month for a business meeting, let's use this time and get to know each other a little better. Dan Coulter brought in left over napkins and placemats from the Ball. This week our daughter, Cathy, was traveling home from college to be with us for Christmas. When she checked in at the airport in College Station (home of Texas A&M where she is a student) she found they had canceled her flight due to mechanical problems with the aircraft. Because of the Christmas holiday, available seats on other flights were almost impossible to find.

The older gentleman said, "Young lady, maybe I can help. Where are you headed?" Cathy told him first to Houston with a connection on to Birmingham. The gentleman got up and went over to speak with the gate agent and came back a short time later. He said, "If it is OK with you, you can fly with me to Houston and make your connection." Not comfortable with "getting a ride from a stranger" Cathy was a bit hesitant. About that time an aircraft taxied up and parked on the tarmac in front of the terminal. On the side of the aircraft was "United States Marine Corps". The gentleman said, "That's my ride, and I can get you to Houston. Would you like to come along?" Cathy quickly responded, "Yes sir" and off they went. When boarding, Cathy noticed several Marine Officers were already in the aircraft. Upon landing in Houston, the older gentleman made sure that Cathy was escorted by two Marine Lieutenants in dress blues through private security screening and all the way down to her gate, catching the eye of everyone in the airport.

The guy runs around to the front of the house and asks the old redneck sitting there "How much do you want for that dog?"

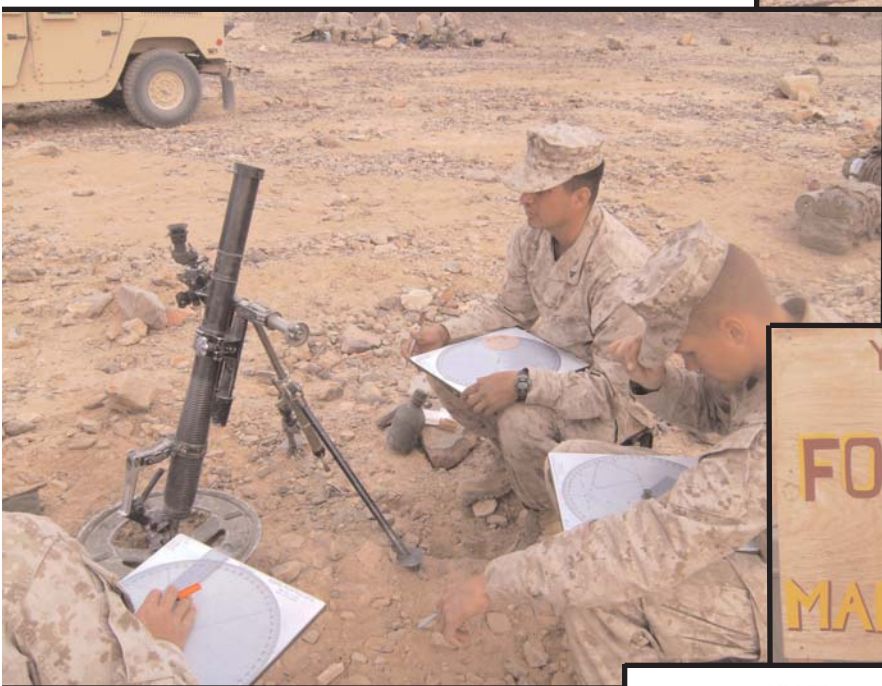
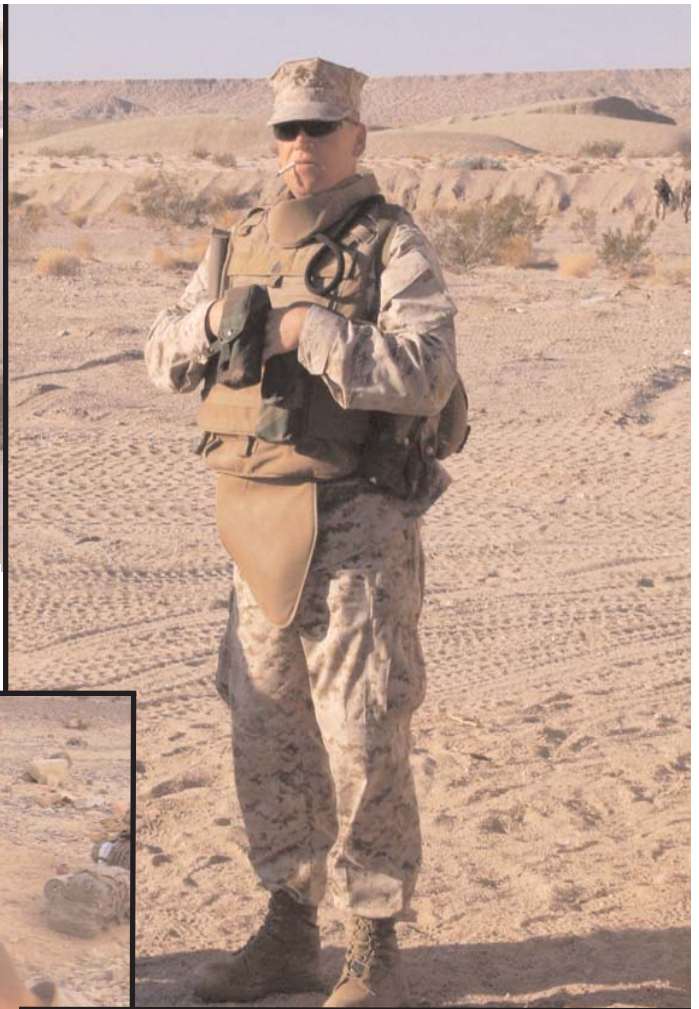
The old redneck replies "\$10.00". The guy can't believe his luck and says, "This dog is amazing. That's pretty cheap for a talking dog who was a hero."








COMMANDANT JOHN STERN REPORTS:

Honor Guard: The Honor Guard did not participate in any functions during the month of December. If any uniformed Member is interested in participating and would like to learn the commands and sequences of a firing detail, contact the Honor Guard Commander and a practice session will be scheduled.

Support the Troops Packages: Spec Nicholas Grief and Sgt. Christopher Rupel were sent packages during December. I encourage the entire KetMorDet membership to submit names, addresses, e-mail addresses and names of the person making the request to me for future mailings. For 2007, the Det. mailed 41 packages totaling 244 pounds, 12 ounces. (I have retained the postal records to substantiate this should anyone inquire as to how funds are spent.) With the deployment of Fox Company, 2/24, the Marine Corps Reserve unit from Milwaukee, the total number of packages KetMorDet sends to the troops during 2008 should easily surpass our 2007 efforts.

DUTIES OF KETMORDET OFFICERS - THROW YOUR NAME INTO THE NOMINATION BIN:

Commandant: It shall be duty of the Commandant to preside at all Detachment meetings; to enforce all rules and regulations; to appoint such officers and committees not otherwise provided for in the By-Laws; to direct the affairs of the Detachment according to the By-Laws and according to the rules and regulations as may be adopted by the Detachment Officers; to perform such other duties as usual for such office.

Senior Vice Commandant: It shall be the duty of the Senior Vice Commandant to give every assistance to the Commandant. In the absence of the Detachment Commandant he will perform the duties of that office. He shall also perform other duties assigned to him by the Detachment Commandant.

Junior Vice Commandant: It shall be the duties of the Junior Vice Commandant to aid the Commandant, and to create membership incentives and programs in order to ensure membership growth. He shall also perform other duties as may be assigned to him by the Detachment Commandant.

Judge Advocate: It shall be the duties of the Judge Advocate to interpret National, Department and Detachment By-Laws; to render opinions when requested by any member during any meeting. The Judge Advocate will always address Detachment Commandant whereupon the Detachment Commandant will rule on the opinion. The ruling shall be final unless appealed and put to a vote. A simple majority of the voting membership is required to reverse the ruling of the Detachment Commandant. He shall also perform other duties as assigned to him by the Detachment Commandant.

Adjutant: It shall be the duties of the Adjutant to keep the minutes of all Detachment meetings, maintain current and accurate membership roster, answer correspondence as directed by the Detachment Commandant; publish notices of meetings to the membership as may be required; maintain records and custody of all Detachment equipment and property. He shall also perform other duties as may be assigned by the Detachment Commandant.

Paymaster: It shall be the duties of the Paymaster to keep financial records of all Detachment business including records of all membership accounts; to hold all monies; pay out money only on approval of the members; to notify all members of dues/fees/ to inform the membership of any indebtedness the Detachment may have incurred. He shall also perform other duties as may be assigned by the Detachment Commandant.

Chaplain: It shall be the duty of the Detachment Chaplain to perform such duties as required by the By-Laws and Rituals of the Marine Corps League. He shall also perform other duties as may be assigned by the Detachment Commandant.

Sergeant at Arms: It shall be the duty of the Sergeant at Arms to preserve order at all meetings. He shall perform such duties as prescribed in the latest edition of the Marine Corps League ritual, and may perform other such duties as assigned by the Detachment Commandant.

Historian: It shall be the duty of the Historian to maintain a record of Detachment activities so as others may be witness to our functions. He shall also perform such duties as assigned by the Detachment Commandant.

ALL OFFICERS SHALL BE ELECTED FOR A TERM OF ONE (1) YEAR, UNLESS REMOVED FOR CAUSE WITH TWO (2) CONSECUTIVE YEARS MAXIMUM FOR THE COMMANDANT, SENIOR VICE, JUNIOR VICE AND JUDGE ADVOCATE.

"ONCE A MARINE"

As I came out of the supermarket that sunny day, pushing my cart of groceries towards my car, I saw an old man with the hood of his car up and a lady sitting inside the car, with the door open. The old man was looking at the engine. I put my groceries away in my car and continued to watch the old gentleman from about twenty-five feet away. I saw a young man in his early twenties with a grocery bag in his arm, walking towards the old man. The old gentleman saw him coming too and took a few steps towards him. I saw the old gentleman point to his open hood and say something. The young man put his grocery bag into what look like a brand new Cadillac Escalade and then turn back to the old man and I heard him yell at the old gentleman saying, "You shouldn't even be allowed to drive a car at your age." And then with a wave of his hand, he got into his car and peeled rubber out of the parking lot. I saw the old gentleman pull out his handkerchief and mop his brow as he went back to his car and again looked at the engine. He then went to his wife and spoke with her and appeared to tell her it would be okay.

I had seen enough and I approached the old man. He saw me coming and stood straight and as I got near him I said, "Looks like you are having a problem." He smiled sheepishly and quietly nodded his head. I looked under the hood myself and knew that whatever the problem was, it was beyond me. Looking around I saw a gas station up the road and told the old gentleman that I would be right back. I drove to the station and went inside and saw three attendants working on cars. I approached one of them and related the problem the old man had with his car and offered to pay them if they could follow me back down and help him.

The old man had pushed the heavy car under the shade of a tree and appeared to be comforting his wife. When he saw us he straightened up and thanked me for my help. As the mechanics diagnosed the problem (overheated engine), I spoke with the old gentleman. When I shook hands with him earlier he had noticed my Marine Corps ring and commented about it, telling me that he had been a Marine too. I nodded and asked the usual question, "What outfit did you serve with?" He had mentioned that he served with the 1st Marine Division at Tarawa, Saipan, Iwo Jima and Guadalcanal. He had hit all the big ones and retired from the Corps after the war was over.

As we talked, we heard the car engine come on and saw the mechanics lower the hood. They came over to us and as the old man reached for his wallet, but I stopped him and said I could just put the bill on my AAA card. He still reached for his wallet and handed me a card that I assumed had his name and address on it and I stuck it in my pocket. We shook hands all around again and I said my goodbyes to his wife. I told the two mechanics that I would follow them back up to the station.

Once at the station, I told them that they had interrupted their own jobs to come along with me and help the old man. I said that I wanted to pay for the help but they refused to charge me. One of them pulled out a card from his pocket that looked exactly like the card the old man had given to me. Both of the men told me then, that they were Marine Corps Reserves. Once again, we shook hands all around and as I was leaving, one of them told me that I should look at the card the old man had given to me. I said that I would as I drove off.

For some reason, I had gone about two blocks when I pulled over and took the card out of my pocket and looked at it for a long, long, time. The name of the old gentleman was on the card in golden leaf and under his name....."Congressional Medal of Honor Society." I sat there motionless looking at the card and reading it over and over. I looked up from the card and smiled to no one but myself and marveled that on this day, four Marines had all come together, because one of us needed help. He was an old man alright, but it felt good to have stood next to greatness and courage and an hour to have been in his presence.

When is the Hand Required to be Held Over the Heart?

Recently, there has been a lot of furor about the photo of a presidential candidate that did not put a hand over the heart during the playing of the National Anthem. The candidate responded to criticism by saying that the photo was taken during the National Anthem, not the Pledge of Allegiance, so it wasn't required to put a hand over the heart.

According to U.S. law, a civilian is supposed to stand up when the National Anthem is played, men should take off their hats, all face the flag, and put their right hand over their heart. When in uniform, members of the military can keep their hats on and salute instead of placing their hands on their hearts. A change to the law in July 2007 authorizes military personnel on active duty who are in civilian clothes, retired military and military veterans to also salute the flag rather than put their hand over their hearts, at their own discretion. They should do either one or the other.

Specific customs for listening to the anthem or reciting the pledge had formulated over the years. The National Flag Conference, an organization made up of representatives from the armed forces and civilian organizations, created a guide to flag etiquette in 1923. But it wasn't until June 1942, when America was fighting WW II, that Congress made this "Flag Code" official.

An aside to this was that the code originally called for the "Bellamy Salute" during the Pledge of Allegiance. The salute was named after Francis Bellamy, who wrote the pledge and published it in *Youth's Companion*, a family magazine in 1892. Bellamy instructed people reciting the pledge to start with their hands on their hearts and then - at the words "to my flag" (later changed to "to the flag of the United States of America") straighten their arms in a military salute. But in the late 1930's, the salute became controversial as people began to realize that this gesture looked quite similar to the arm movement favored by the Nazis in Germany. Schools in New York, New Jersey and elsewhere began to alter the salute, and in late 1942, it was eliminated from the code in favor of keeping the hand on the heart, as most patriotic Americans do today.
