**Newsletter:** The Editor asked Members to contact him about their bio's. Comments keep coming in as to how good the *Kettle Moraine Marine* Newsletter is, but Member input is needed to keep it going. The limited edition RED KetMorDet T-Shirt was given to Fritz Montag, Dan O'Toole, and John Fleischman for each having obtained donations for at least three of the 2007 Newsletter ads. Members participating in any KetMorDet events are asked to take photos for the Newsletter and Historical purposes. The Historians cannot make it to all the events, and are asking for help on this.

**Fundraising:** John Stern contacted the West Bend Walmart and confirmed June 29, 30, and July 1 as dates for a Marine Rose Distribution Fundraiser. Because of a new store policy to keep dates open for all groups, subsequent dates cannot be made until the first fundraising date has passed. Cal Racine is checking into the Memorial Day weekend date at Saukville and will report back.

Jim Krudwig said that he has arranged for and the Det. has paid for 15,000 Marine Roses for the upcoming year to be purchased and assembled by an impaired workshop group. Previously, the Paymaster had to shop around for good prices for materials and then find a place to have them assembled. The price is the same as last year except that they do the purchasing and assembly all at the same facility.

Jim said that someone from the Det. should contact the Milwaukee Brewers before all the good open dates are gone. John Stern suggested that the Badger Det. be contacted before doing a fundraiser in Milwaukee. Jim said that, in the past, the Badger Det. Commandant had suggested that KetMorDet do fundraisers at Miller Park and had asked KetMorDet to arrange some dates for Badger as well. Jim will make the contact.

#### **Old Business**

A straw poll was taken to see if there was still interest in helping to bring a Marine Band to the area over the mid-August Allenton Parade weekend. The discussion had come up previously and Charlie Keller had asked Jim Krudwig last year about having the band also provide a concert in West Bend that weekend. The cost to bring a Marine Band in would be split between the Allenton Parade group, the West Bend Parade Committee and KetMorDet, which would be responsible for approximately 1/3, which is estimated to be about \$3000. This would benefit both the Detachment and Marine Corps recruiting. The biggest issue would be KetMorDet Member participation in crowd control during the festivities. It will take a concerted Det. effort from all to get it done. Members agreed that it would be a good idea to help sponsor this and to look into it further. Jim Krudwig will report back as something develops.

#### **New Business**

Elections were held prior to the Meeting with the results being read at the beginning. All positions were filled as noted on the ballots. Don Erdman reluctantly had to turn down the Sr. Vice Commandant billet due to medical/personal reasons. As there were no volunteers for this position, the incoming Commandant, John Stern, stated that per Det. Bylaws, he would appoint someone to this billet if no one comes forward and volunteers for it. The Dept of WI MCL Commandant, Tim Baranzyk, will be on hand at the March meeting to install all of the Officers. Congratulations and good luck to the new board of Officers. Thanks go out to those leaving their current billets for a job well done. Marines being installed as Officers were asked to wear their black KetMorDet t-shirt and black trousers for the event.

Jim Krudwig said that State Commandant Baranzyk asked at the Winter Dept Meeting in Jan. that all Detachments purchase a "Fallen Warrior" statue to be given to local families of those Marines killed in combat during the current hostilities. The statues cost \$230 each. John Stern asked if there was room on the statue to engrave it indicating that it was from KetMorDet. Gil Lucka stated there is room on the bottom for a brass plate with the info. Wally Huf stated that the original full size statue is in Madison, and that the names of the fallen are added to it. Gil Lucka stated he has one of these statues and that it could be used if needed. Dan O'Toole made a motion to replace Gil Lucka's statue if his is ever needed. Roger Cross seconded and the motion carried.

Also at the Jan. winter meeting, Dept of WI Veterans Affairs rep, Jeff Johnson who is a retired Marine MSgt, asked that all MCL Det's work closely with the Marines and other veterans returning from tours in war zones to assist them if possible.

The Adjutant, Jason Waier, said that an advertising company has been in contact with him at his regular job. One of the items they offer is a pen with advertising on it. The pens could have an EGA emblem, the Det's full name, address, and contact info printed on them. It could be given out to Members, at fundraisers and other events, and would be a good source for getting some advertising out about KetMorDet. Gil Lucka made a motion to purchase 500 of these pens. Bill Wallace seconded and motion carried. After the vote, it was brought up that Member Brian Rahn also sells similar advertising items. Jason said that he would contact him and see what kind of price he could get on the pens. If it is close in price, the Det. could purchase them from Brian.

#### **Meeting Closed**

With no further business to be conducted, the outgoing Commandant, Tim Bertram, thanked the Detachment for the opportunity to serve as Commandant for the 2006 year and wished the new Officers luck in their endeavors. He then gave the order to close the Meeting. The Sgt at Arms retired the Colors, the Chaplain gave the closing prayer, and the Sr. Vice Commandant thanked all for attending and asked that they secure new members. The Meeting closed at 0955 hrs. The next meeting will be held at 0900 hrs on March 17th, 2007 at the Trenton Town Hall.

## Marine S.O.S.

It's said that an Army fights well on a full stomach and the Marine Corps is no exception. Always and foremost, in training or in combat, the breakfast meal is number one. For every "grunt", "airedale" and/or "pinky" at the start of the workday. Breakfast is the link to "making it" that day, and "a breakfast without SOS is like a day without sunshine."

We can only imagine or guess at what the meals and types of food were being served at Tunn's, or with O'Bannon in Tripoli, but I'll bet you, they had some sort of S.O.S.

The original creamed ground beef now served at every Marine breakfast had many stories of origin, the story that I was told was, that it was first served during World War I in France.

The Marine forces on the line were served meals that were prepared by the Army, from field kitchens in the rear. On this one occasion during a battle, the Marines moved so fast forward that the Army Mess Company couldn't keep up with the advancement. On that particular evening the cooks had prepared a meal which was roasted beef with a cream gravy (Boeuf le Creme de Argonne) and sent it up to the front lines.

It took the mess men all night to find the location of the fast moving Marine Brigade, and the meal was not delivered until the next morning.

Not wanting to waste the food and not having the tools to serve it properly, the Marine First Sgt. ordered that the meat and gravy (sauce) be placed on the dry bread and handed to each man. The men being very hungry did not complain but instead requested that this meal be served again, but with the proper utensils.

Over the following years the recipe changed depending on the availability of supplies and the mood of the cook. Do to the lack of funds given to the Marine Corps by the Navy, especially in hard times (like now), many of the cooks could not afford to purchase the beef roasts needed in the recipes for "Boeuf le Creme de Argonne" and other beef dishes. They therefore substituted the less expensive, ground beef in place of the roasts.

This was quite popular as an evening meal and was served a number of times a week. One big advantage that the cooks liked was that there was little or no waste, leftovers could be served the next morning. It grew in popularity more for breakfast than for the evening meal and today it's never served other than for breakfast.

The other branches of service (Army, Navy, etc.) will also serve their version of SOS, but they haven't mastered the Marine's technique of preparing this marvelous breakfast presentation. The Army uses chipped and salted dried beef (yuk), and the Navy uses beans and tomatoes in their recipe (barf !), the Air Force gave up trying and our friends in the Coast Guard now eat breakfast in the nearest Marine mess hall.

A number of years ago (back in the 70's), San Francisco's own Marine Artillery General (Brigadier) Tiago, requested/ordered that a recipe for the Marine Corps famous S.O.S. (creamed beef on toast) be developed so that it could be serve to a small group of about eight (8) persons, this way the general could have his wife make it at home. The official recipe for the mess halls is for serving 300 or more. This challenge was taken up by his chief field artillery cook, M/Sgt Bernie Parker. After many tries and a few mistakes "Top" Parker came up with the following, near perfect, recipe.

Recipe for "Marine Breakfast"

(Serves 8 or two hungry Marines)

1/2 lb. Ground Beef (ground chuck for flavor)

1 tbs. Bacon fat (lard/Crisco or butter)

3 tbs. Flour

2 cups Whole milk (add more milk if you want it thinner)

1/8 tsp. Salt

Pepper (to taste)

8 slices of dry toast

Using a large skillet (12"-14"), crumble and brown the ground beef with the fat and salt, remove the pan from the heat and let cool slightly.

Mix in the flour until all of the meat is covered, using all of the flour. Replace the skillet on the heat and stir in the milk, keep stirring until the mixture comes to a boil and thickens (boil a minimum of 1 minute).

Serve over the toast. Salt & pepper to taste. "Semper fi"

## JIM LEHRER'S SPEECH AT THE OPENING OF THE MARINE CORPS MUSEUM

*On, November 10th, 2006, the 231st anniversary of the Corps, PBS News Hour's Jim Lehrer gave a very interesting talk on his time on active duty at the dedication of the National Museum of the Marine Corps in Quantico.*

Mr. President, generals, colonels, majors, captains, lieutenants, warrant officers, sergeants, corporals, privates, ladies and gentlemen.

We are the Marines. And in this museum, our story is told. It is a single, monumental story, made up of 231 years of many separate stories of heroism and courage, of dedication and sacrifice, of service to our country and to our Corps, of honor and loyalty to each other in war and in peace; 231 years of professionalism and pride, of squared corners and squared-away lockers, perfect salutes and good haircuts, well-shined shoes, and eyes right, 231 years of Semper Fi's and DI's.

The first time I came to Quantico was 51 years ago. I came as an officer candidate, a PLC on the train from Washington, having just traveled from Texas on the first airplane ride of my life. On the orders of a drill instructor, a DI, I fell in at attention with 40 other candidates on the platform at the train station over at Quantico.

And the DI told us to answer up, "Here, sir!" when our name was called. And he got to mine and he said "Le-here-er-er" And like some kind of idiot, I blurted out, "It's pronounced Lehrer, sir!" There was silence, absolute silence. And then I heard the terrifying click, click, click of leather heels on the deck of that train station platform coming in my direction. And suddenly there he was, the DI, right in front of me, his face right up in mine. And I paraphrase and cleanse it up a bit, but he said, "Candidate, if I say your name is Little Bo Peep, your name is Little Bo Peep!" "Do you hear me?"

Oh, I heard him all right. And I think it was at that very moment that I really became a United States Marine. I'm still one today and I will remain one forever, as did my late father, and as is my older and only brother. I came from a family of Marines into the family of Marines. My father served in the 1920s under the great Smedley Butler right here at Quantico. He saw combat in Haiti and came out a corporal. My brother and I were both 1950s Cold War Marines in the Third Marine Division in the Far East.

Since our Corps was founded on this day in 1775, there have been more than 4 million men and women who have worn the uniform of a United States Marine. This museum is about all of them, including us three "Le-here-er-ers," and even the Little Bo Peeps. That's because this museum is about what it means to be a Marine, no matter the time, the length, place, rank, or nature of the service.

It's about the shared experience the shared knowledge that comes from being a U.S. Marine, such as knowing that you are only as strong and as safe as the person on your right and on your left; that a well-trained and motivated human being can accomplish almost anything; that being pushed to do your very best is a godsend; that an order is an order, a duty is a duty, that responsibility goes down the chain of command, as well as up, as do loyalty and respect; that leadership can be taught, so can bearing, discipline and honor; that "follow me" really does mean "follow me"; and that Semper Fidelis really does mean "always faithful"; and that the Marine Hymn is so much more than just a song.

My Marine experience helped shape who I am now personally and professionally, and I am grateful for that on almost a daily basis. And I often find myself wishing everyone had a similar opportunity, to learn about shared dependence, loyalty, responsibility to and for others, about mutual respect and honor, and about the power of appealing to the best that's in us as human beings, not the worst.

As a journalist, there has been one overriding effect of my Marine experience: While debates over sending Americans into harm's way are always about issues of foreign policy, geopolitics and sometimes even politics-politics, for me, they are also always about young lance corporals and second lieutenants and other very real people in all branches of the U.S. military, people with names, ranks, serial numbers, faces, families, and futures that may never be.

When Marines stand for or sing the Marine Hymn, as we will at the conclusion of this ceremony, it's never for ourselves personally. It's always for the Marines who went before us, with us, and after us, first and foremost for those who gave their lives, their health, their everything at places such as Tripoli, Belleau Wood, Haiti, Wake Island, Guadalcanal, Pelilu, Iwo Jima, Chosen, Inchon, Danang, Khe Sanh, Beirut, Baghdad, Fallujah and Ramadi.

The death rate among Marines in Iraq has been more than double that of the other services. That's a first-to-fight, first-wave pattern that has pretty much held since the Revolutionary War, when 49 of the very first U.S. Marines of our country died in combat. Their mission was aboard ship; there are still Marines who serve at sea.

There are others who fly and maintain jets and helicopters, man the artillery, operate tanks and trucks, feed and supply the troops, compute and collate, train and inspect, march and make music, recruit, guard and escort, radio and communicate, patrol and snipe, as well as save tsunami, earthquake and other disaster victims around the world, collect toys at Christmastime for American kids in need, stage a marathon run through Washington, D.C., for charity, or do whatever else needs to be done, particularly if the need is for it to be done well and done immediately.

We are the Marines, And in the language of the rifle range, we are always ready on the right, ready on the left, all ready on the firing line, whatever kind of firing is required and wherever that line may be.

He told me not to worry about Marine X because every time I send something to him; Marine X thinks it is for him as well. He said that when the last care package that my husband and I sent arrived, Marine X came over to his cot and picked up the box, started fishing through it, and asked "What did we get this time?" Apparently, they had the most fun with Marine X's 'female' care package. They weren't sure who that package was meant for but the panties in it were size 20 and one of the guys got on top of the Humvee and jumped off with the panties over his head, yelling 'Look at me, I'm an Airborne Ranger!!!' I am absolutely amazed by the ingenuity of our Marines, and can't believe that something that started out as a mistake, then turned into a joke, ended up saving someone's life. My sister said that she doesn't believe in mistakes. She believes that God had a plan all along. She believes that the 'female' care package was sent to Marine X to save the Marine who was shot. Either way, our efforts have boosted the morale of many Marines, provided much needed items for our troops, AND saved the life of a Marine! God bless every one of you for your efforts and hard work, and God bless our Marines, Army, Navy, Air Force and everyone. GOD BLESS AMERICA AND KEEP IT SAFE!
