Calls have been made to Ken Brown to see if they have someone ready to go on the next Honor Flight for the Detachment to sponsor, but he has not called back.

It would be run bi-monthly the weekend prior to our Meeting for the next 10 months and not to exceed \$160. Seconded by John Fleischman. Motion passed.

The Milwaukee Military Historians meet the 3rd Monday of every month at the American Legion Hall in Grafton. There is dinner followed by a guest speaker every month. An Iwo Jima Marine was the guest speaker in February. It costs \$8 to hear the speaker only or \$20 for dinner and the speaker. Four Lakes Detachment held a Spaghetti Dinner fundraiser in Madison Jan 31st to raise money for the Fallen Warrior statues that are being given to all the Wisconsin families that have lost someone due to the War on Terror in Iraq or Afghanistan. Rollie Moericke and Jason Waier attended on behalf of the Detachment. They were happy and surprised to see that we traveled that far to support them. They had local TV news coverage and were very well prepared. I am sure that they met their goal of 300 people.

**Fundraising:** Jason Waier contacted Mike Serio of the Milwaukee Brewers to see if there were any fundraising dates still open at Miller Park for fundraising. Mr. Serio stated that there were some still open but they were filling up fast and suggested we submit a request soon. As time was imperative the Adjutant did submit for and receive three fundraising dates: April 10th, and 11th (home opening weekend against the Cubs), and August 16th against Houston. Please keep these dates open and help the Detachment during these fundraisers. These have always been good events for the Detachment and with a good turnout can be again this year.

Officer voting ballots were collected from 0845-0900 and counted at the opening of the Meeting. The Sr Vice and Adjutant verified the ballots. All 20 Members present turned in ballots. There were again 2 blank ballots turned in this year. The remaining 18 were checked and all nominated Officers were elected and will be sworn in on March 21st by the State Commandant Vern Riedle. Congratulations to our 2009-2010 Officers. Be sure to come to the March Meeting and welcome them and meet Vern Riedle. Danny O'Toole made a motion for \$100 (\$50 cost) savings bonds be given to all future Eagle Scouts during their Court of Honors that the Det attends. Seconded by Jim Krudwig. Motion passed. Jim Krudwig noted that most other Det's have their name sewn onto their red MCL covers and suggests that KetMorDet does the same. John Stern stated that he would look into doing so per MCL uniform rules and report back next month. Jason Waier noted that he has unofficially been looking into prices of renting/leasing a more permanent Detachment home. A place that could be used for fundraisers, or a Toys for Tots drop off location, a place where Members could get together for things other than just Meetings, and could also store all the Det gear. John Fleischman made a motion that Jason chair a committee to look into finding a "home" for the Detachment. Seconded by Tim Bertram. Motion passed 19-1. He will talk to the city building inspector, and get more prices on locations and report at the March Meeting his findings. ## ORIGIN AND EVOLUTION OF TOYS FOR TOTS

Toys for Tots began in 1947 when Major Bill Hendricks, USMCR and a group of Marine Reservists in Los Angeles collected and distributed 5,000 toys to needy children. The idea came from Bill's wife, Diane. In the fall of 1947, Diane handcrafted a Raggedy Ann doll and asked Bill to deliver the doll to an organization, which would give it to a needy child at Christmas. When Bill determined that no such agency existed, Diane told Bill that he should start one. He did. The 1947 pilot project was so successful that the Marine Corps adopted Toys for Tots in 1948 and expanded it into a nationwide campaign.

The initial objective that remains the hallmark of the program today is to "bring the joy of Christmas to America's needy children." Bill Hendricks, a Marine Reservist on weekends, was in civilian life, the Director of Public Relations for Warner Brothers Studio. This enabled him to convince a vast array of celebrities to support Toys for Tots. In 1948, Walt Disney designed the Toys for Tots logo, which is still used today. Disney also designed the first Toys for Tots poster used to promote the nationwide program. Nat "King" Cole, Peggy Lee, and Vic Damone recorded the Toys for Tots theme composed by Sammy Fain and Paul Webster in 1956. Bob Hope, John Wayne, Doris Day, Lorrie Morgan, Tim Allen, Kenny Rogers and Billy Ray Cyrus are but a few of the long list of celebrities who have given their time and talent to promote Toys for Tots. First Lady Nancy Reagan served as the national spokesperson in 1983. First Lady Barbara Bush served as the national spokesperson in 1992 and in her autobiography named Toys for Tots as one of her favorite charities.

From 1947 through 1979, Marines collected and distributed new and used toys. On Reserve drill weekends during October, November and December, Reserve Marines refurbished the used toys. From Christmas 1980 through the present, Marines have collected and distributed only new toys.

Three factors dictated this change:

*First*, the Secretary of Defense's Total Force Program, introduced in the 1970's, assigned Reserves a greater role in America's defense posture. As a consequence, Reservists had to dedicate every minute of weekend drill time to honing and polishing combat skills. No time was available to refurbish toys.

*Second*, public awareness of the health and safety aspects of toys that developed during the 70's made distribution of used toys legally inadvisable.

*Third*, distributing "hand me down" toys does not send the message Marines want to send to needy children. The goal is to deliver a message of hope, which will build self-esteem and, in turn, motivate needy children to grow with responsible, productive, patriotic citizens and community leaders. A shiny new toy is the best means of accomplishing this goal.

In 1995, the Secretary of Defense approved Toys for Tots as an official activity of the U. S. Marine Corps and official mission of the Marine Corps Reserve.

In 1996, the Commander, Marine Forces Reserve expanded Toys for Tots to cover all 50 states by authorizing selected Marine Corps League Detachments and selected local community organization (generally veteran Marines), located in communities without a Marine Reserve Center, to conduct toy collection and distribution campaigns in their communities as part of the U.S. Marine Corps Reserve Toys for Tots Program.

Over the 62 years of the U.S. Marine Corps Reserve Toys for Tots Program, Marines have distributed more than 370 million toys to more than 173 million needy children. This charitable endeavor has made U.S. Marines the unchallenged leaders in looking after needy children at Christmas. Over its 18 year life span, the Marine Toys for Tots Foundation has supplemented local toy collections with more than 70.2 million toys valued at more than \$387 million; plus has provided promotion and support materials valued at over \$4.7 million.

Apparently, these same Members who are non participants in the FHP are offended by this use of rank. We could bring it up at a Det meeting for discussion. Still another question came up from these disgruntled Members about my expending \$91 of Det funds to have the FHP letters with color photos on the reverse side printed up on stationary to be sent out to schools, nursing homes, civic groups, scouts, etc. Also postage was paid to send out those letters. This discussion comes from one Member who has, in the past, stated that he does not care to distribute roses in fundraising because it is "begging for money". When he was scheduled to run a fundraiser, he showed up in the morning to drop off the cans and roses and came back in the afternoon to pick up the money and gear. One wonders where our Det funds would be should we all think the same and not conduct the rose distribution. The Det fund would be pretty low if it relied solely on other sources. The second Member was the aforementioned individual who forgot to forward the FHP request to me for three months. He had, in the past, authorized excessive and unapproved expenses for a Det Birthday Ball. On a later occasion, he attempted to spend several hundred dollars of Det funds for something that had not been discussed or approved by the Det. As a result, a majority of the sitting Det Officers proposed and a change to the by-laws was made by the membership so that nobody can expend more than \$100 without approval by the Members at a meeting. So, as the FHP Team Commander and sitting Det Historian, I expended \$91 for 200 copies of the FHP letter. Should the membership as a whole feel that I did something wrong, I will reimburse the Det for that amount. It should be noted that the Det sometimes receives donations from \$25 to \$200 for our conducting FHP's, probably bringing in up to \$500 a year to the Det fund.

Finally, our Adjutant brought up the idea at the Feb meeting that the Det should consider renting a permanent site where meetings can be held and to store the ever increasing Det equipment all in one place. This would include bringing the rifles which are currently stored in a Member's residence in the country to the proposed meeting place in town should a new Det Hqs. be selected. In the past the Det discussed purchasing a weapons storage safe. I have a proposal to make to the Det to obtain such a safe. I have a full unsealed bottle of Jim Beam Bourbon Whiskey in a collector decanter showing a Marine Devil Dogs logo. It was distributed by the James B Beam Distilling Company around 1979 and has a value of \$450 to \$475 per a note from a collector found on [www.google.com/ebay](http://www.google.com/ebay). I have held this bottle for several years trying to figure how it can best be used. Either the Det Members could bid on it or I could put it up for sale on eBay with the proceeds used to go for the purchase of a KetMorDet rifle safe. This also could be discussed at a Det meeting.

**KETTLE MORAINÉ MARINE NEWSLETTER:** In January 2005, the Dept of WI Commandant of the Marine Corps League set up an information meeting in Jackson to see if there was interest in establishing a new Detachment in Washington and Ozaukee Counties. Several prospective Members were in attendance. Tim Bertram and I took it upon ourselves to set up a meeting. I arranged for our first meeting to be held at the Chase Bank Building (old Bank One) in West Bend on Feb 19th, 2005 and published an information bulletin which was sent out to prospective Members. I published our first four page Newsletter in March advising that 17 possible Members had attended with six signing up to be charter members. Tim agreed to take on the Acting Commandant position while I volunteered to do the Paymaster, Newsletter, and Fundraiser responsibilities. Several others offered to assist. At our second meeting on March 12, 2005, reported in issue 2 of the four page Newsletter, a group of acting officers was selected and annual dues set at \$30. Discussion about preparation of Det By-Laws, celebration of the Marine Birthday Ball, fundraising for charities and Det. activities and equipment purchases was conducted. I purchased American, Marine, and POW/MIA colors to be used until the Det later had adequate funds to purchase parade flags in August. The red KetMorDet windbreaker jacket was displayed and orders taken. The third issue of the Newsletter published in May discussed the April meeting. We needed 20 Members to submit a request for the Det's charter so I visited prospective Members at their homes and restaurants. We ended up with 28 paid Charter Members. I arranged to purchase 10,000 miniature roses and several Members and their wives assembled them with labels obtained at the last minute. Our first fundraiser two days later was held in Saukville on Memorial Day 2005. That first fundraiser brought in \$2767. After repaying me for expenses incurred up to then (printing, flags, gavel, etc), the Det was solvent with over \$2000 in the bank. The June Newsletter issue advised that the State Commandant would swear in the officers and all Members at the June 18th meeting. The black KetMorDet t-shirts were approved and purchased to be given to those Members who participate in Det activities like fundraising and Honor Guard. I continued to edit the Newsletter alone through June and July until Jason Waier agreed to become the Graphics Editor in August 2005. Our Newsletter became much better looking as a result of Jason's magic with photos and graphics. We earned a national honorable mention award for it in 2007.

So, it is with some regret that I give up this position of newsletter editor but realize that new ideas and viewpoints are needed to keep it fresh. Also, I am a bit worn out by the job of writing articles, assembling and mailing it after over four years. I will be available to assist Jason when needed and may occasionally throw in an article just to keep involved. Let's all support Jason in taking on the job as the new Editor of the *KETTLE MORAINÉ MARINE*.

## BE AWARE OF WHO YOU SEND YOUR MONEY TO

Among other things, the rating chart shows fund raising costs per \$100 raised for each charity. Some of the figures are truly shocking!

Americans gave millions of dollars in the past year to veterans charities designed to help troops wounded in Iraq and Afghanistan, but several of the groups spent relatively little money on the wounded, according to a leading watchdog organization and federal tax filings.

Eight veterans' charities, including some of the nation's largest, gave less than a third of the money raised to the causes they champion, far below the recommended standard, the American Institute of Philanthropy says in a report. One group passed along 1 cent for every dollar raised, the report says. Another paid its founder and his wife a combined \$540,000 in compensation and benefits last year, a Washington Post analysis of tax filings showed.

Richard H. Esau Jr., executive director of the Military Order of the Purple Heart Service Foundation, based in Annandale, said the cost of fundraising limits how much his group can spend on charitable causes. 'Do you have any idea how much money it costs to advertise? It's unbelievable the amount of money it takes to advertise in the print and electronic media,' he said. 'I'm very proud of what we do, and we certainly do look after everybody. The point is we do the right thing by veterans.'

Borochoff said many veterans charities are 'woefully inefficient,' spending large sums on costly direct-mail advertising. 'They over solicit. They love to send out a lot of trinkets and stickers and greeting cards and flags and things that waste a lot of money that they get little return on,' said Borochoff, who plans to testify before Congress today.

The philanthropy institute gave F's to 12 of the 29 military charities reviewed and D's to eight. Five were awarded A-plus-es, including the Fisher House Foundation in Rockville, which the institute says directs more than 90 percent of its income to charitable causes.

One group received an A, and one received an A-minus...

Jim Weiskopf, spokesman for Fisher House, said the charity does not use direct-mail advertising. 'As soon as you do direct mail, your fundraising expenses go up astronomically,' he said.

One egregious example, Borochoff said, is Help Hospitalized Veterans, which was founded in 1971 by Roger Chapin, a veteran of the Army Finance Corps and a San Diego real estate developer. The charity, which provides therapeutic arts and crafts kits to hospitalized veterans, reported income of \$71.3 million last year and spent about one-third of that money on charitable work, the philanthropy institute said.

In its tax filings, Help Hospitalized Veterans reported paying more than \$4 million to direct-mail fundraising consultants. The group also has run television advertisements featuring actor Sam Waterston, game show host Pat Sajak and other celebrities.

Bennett Weiner, chief operating officer of the Better Business Bureau, said the agency has 20 standards for reviewing charities, including that a charity's fundraising and overhead costs not exceed 35 percent of total contributions.

The American Institute of Philanthropy, a leading charity watchdog, issued a report card this month for 29 veterans and military charities. Letter grades were based largely on the charities' fundraising costs and the percentage of money raised that was spent on charitable activities. The charities that received failing grades are in bold type:

NCOA Participates in US Supreme Court Case

**BRIEF AMICI CURIAE OF THE AMERICAN LEGION, VETERANS OF FOREIGN WARS OF THE UNITED STATES, THE MILITARY ORDER OF THE PURPLE HEART, INC., THE NON COMMISSIONED OFFICERS ASSOCIATION OF THE USA, VETERANS OF THE VIETNAM WAR, INC. & THE VETERANS COALITION; AND AMERICAN EX-PRISONERS OF WAR IN SUPPORT OF PETITIONER**

Congratulations! We won! Yesterday the US Supreme Court handed down its opinion in Pleasant Grove City v. Summum and upheld the right of governments everywhere to erect what otherwise lawful monuments they may choose without having to erect any monument any group wants to make them erect. In relevant terms, this means governments from the local to the federal level can continue to commemorate our veterans with memorials without having to tear them down or put up monuments that might dishonor our veterans. This is huge. Because of your involvement in this case, the Court referenced or discussed veterans memorials in at least half a dozen places in its opinion, at one point citing directly to YOUR brief. Perhaps most significantly, on page 17 of the opinion the Court directly recognized a main point of your brief as "well founded:" had Summum gotten its way, "[e]very jurisdiction that has accepted a donated war memorial may be asked to provide equal treatment for a donated monument questioning the cause for which the veterans fought." The Court decided that this was an unacceptable result.

Just so we're clear, you just helped write the law. And you just helped write it in such a way that protects and defends the honor of anyone who has ever worn the uniform. On behalf of myself and the other veterans at this firm, thank you for your willingness to stand. We're proud to have stood with you. You should let your members and the public know what you've done.

Again, congratulations. You stood for the right and the right was upheld.

## SOME ADDITIONAL HISTORY ON THE MAMELUKE SWORD

A Mameluke sword is a cross-hilted, curved, scimitar-like sword historically used by Mamluk warriors from whom the sword derives its name. It is related to the shamshir, which had its origin in Persia from where the style migrated to Indian, Egypt and North Africa. It was adopted in the 19th century by several Western militaries, including the French Army, British Army and the ceremonial Side arm for some units to this day....

Marine Corps lore states that a sword of this type was presented to Marine First Lieutenant Presley O'Bannion by the Turkish viceroy, Prince Hamet, on Dec 8, 1804, during the First Barbary War, as a gesture of respect and praise for attempting to return the prince to his throne. Upon his return to the United States, the State of Virginia presented him with a silver hilted sword featuring an eaglehead hilt and a curved blade modeled after the original Mameluke sword given him by Hamet. Its blade is inscribed with his name and a commemoration of the Battle of Tripoli Harbor.

Perhaps due to the Marines' distinguished record during this campaign, including the capture of the Tripolitan city of Derna after a long and dangerous desert march, Marine Corps Commandant Archibald Henderson adopted the Mameluke sword in 1825 for wear by Marine officers. After initial distribution in 1826, Mameluke swords have been worn except for the years 1859-75 (when Marine Officers were required to wear US. Model 1850 Army Foot Officers' Sword), and a brief period when swords were suspended during World War II. Since that time, Mameluke swords have been worn by Marine Officers in a continuing tradition to the present day.

Mameluke swords were carried as dress swords by Officers of most light cavalry and hussar, and some heavy cavalry regiments in the British Army at various points during the 19th century, started in the period after Waterloo. The current regulation sword of generals, the 1831 Pattern is a Mameluke-style sword as were various Army Band swords. The US Marine Corps Officers sword has been suggested as also being influential. The 1831 Pattern General Officers' Sword is, indeed, very similar to the USMC Mameluke that pre-dated it.

Napoleon raised a number of Mameluke units during his Egyptian campaigns in the French Revolutionary Wars. The Duke of Wellington carried a Mameluke sword from his days serving in India.
