**Reading of the Minutes**

During the Feb Meeting, a motion was made for the Detachment to reimburse Gil Lucka for his Fallen Warrior statue if it was ever needed. **Report of Standing Committees**

**Honor Guard Team:** The Honor Guard has not participated in any events this month.

**Flag History Presentation Team:** The Boy Scouts in Cedarburg sent a Thank you note for the FHP program conducted for them during March. Several new dates have been set up including: St. Francis Cabrini Scouts in West Bend April 26th; Christ Lutheran Church Scouts in Jackson April 30th; Peace Church in Kewaskum May 16th with dinner at 1730 followed by the program at 1830; Hartford Health Care at 0930 May 18th. A FHP will be conducted on May 15th at 1800 at Ridge Run Park for a Scout Pack/Troop. **Fundraising:** The Commandant is looking for a Member to chair the committee for this important KetMorDet function. Fundraising is the backbone for many aspects of this Detachment. Everything we do costs money. Donations to charitable organizations are a prime example of the need for fundraising. Equipment is expensive. Several fundraisers for 2007 have already been scheduled and others are planned. The first scheduled Rose Distribution fundraiser for 2007 will be at Walmart in Saukville on Memorial Day weekend. This will be followed by a two day Rose Distribution at Miller Park prior to the Brewers/Cubs games on Mon-Tue June 4 & 5 and the Brewers/St Louis games on Aug. 14-15 & 16. Other scheduled dates are: Walmart in Germantown on July 6, 7, 8 and again on Aug 31, Sept 1 and 2. A brat fry at Piggly Wiggly in Kewaskum is scheduled for Aug 11.

### Old Business

The Sr Vice Commandant asked Jim Krudwig to go over the details of getting the Marine Band for a performance in mid-August. The Band would be available to possibly play the National Anthem Aug. 16th for an afternoon Brewer game at Miller Park. A rose fundraiser is also scheduled at Miller Park that day by either KetMorDet or Badger Det. On Aug. 17th, the band would tentatively have a free West Bend concert for the public, at a venue not yet determined. The Band is doing a Change of Command Ceremony in Chicago on Aug. 18th. They then will march in the Allenton Parade Aug. 19th. A high estimate of \$10,000 for the entire weekend includes food and lodging for the Band will have to be covered by supporting units which would include KetMorDet and the Allenton Parade group. Several Members voiced that they felt it would be a great public relations coup for KetMorDet to sponsor having the Marine Band here even if it meant the Det. might have to pay the entire bill itself. Dan Coulter stated he would work with the Allenton area to raise funds for this effort. Paul Bollmann stated he would work with Roger Cross in the West Bend area. Dan O'Toole agreed to work in the Germantown area. With the Allenton Parade Group having agreed to cover half the expense, the Detachment would be responsible for the balance of the amount that could not be raised from Corporate donations. Knowing this could cost the Detachment up to half of the entire high estimated \$10,000, the Members present still felt that planning for this should continue even if no funds could be raised. Paul Bollmann made a motion to go ahead with the planning and affirm the schedule. Seconded by Dan Coulter. Motion Carried. The Commandant will be contacting Members to work on this project and forming a committee.

### New Business

Another MCL Detachment is beginning to form in Ozaukee County. State Commandant Baranzyk originally envisioned the area of operation for KetMorDet being Washington/Ozaukee Counties. Now it is felt that there is enough area to cover for 2 Detachments to exist. Members may see pamphlets that are being distributed by the proposed Ozaukee County Det.

Jim Krudwig was asked to speak at a Marine recruit "poolee" dinner by the local recruiters. Following his speech, he was presented with a Viet Nam era Marine K-Bar by Gunny Merrill. Over 200 family members were present for the function. It was an entertaining and insightful evening with five Drill Instructors from both San Diego and Parris Island present to answer questions from eager parents. Lots of interesting questions by concerned mothers.

### Meeting Closed

With no further business to be conducted, the Sr. Vice Commandant gave the order to close the Meeting. The Sgt at Arms retired the Colors, the Chaplain gave the closing prayer, and the Sr. Vice Commandant thanked all for attending and asked that they secure new members. The Meeting closed at 1015 hrs. The next meeting will be held at 0900 hrs on May 19th, 2007 at the Trenton Town Hall.

## **VIETNAM WAR FACTS:**

### **Facts, Statistics, Fake Warrior Numbers and Myths Dispelled**

9,087,000 military personnel served on active duty during the official Vietnam era from Au 5 1964 to May 7, 1975.

2,709,918 Americans served in uniform in Vietnam.

240 men were awarded the Medal of Honor during the Vietnam War.

The first man to die in Vietnam was James Davis in 1958. He was with the 509th Radio Research Station.

58,148 were killed in Vietnam.

75,000 were severely disabled.

23,214 were 100% disabled.

5,283 lost limbs.

1,081 sustained multiple amputations.

Of those killed, 17,539 were married

11,465 of those killed were younger than 20 years old.

Average age of those killed was 23.1 years.

Five men killed in Vietnam were only 16 years old.

The oldest man killed was 62 years old.

As of January 15, 2004, there are 1,875 Americans still unaccounted for from the Vietnam War.

97% of Vietnam Veterans were honorably discharged.

91% of Vietnam Veterans say they are glad they served.

74% say they would serve again, even knowing the outcome.

Vietnam veterans' personal income exceeds that of our non-veteran age group by more than 18 percent.

87% of Americans hold Vietnam Veterans in high esteem.

There is no difference in drug usage between Vietnam Veterans and non-Vietnam Veterans of the same age group (Source: Veterans Administration Study).

Vietnam Veterans are less likely to be in prison - only one half of one percent of Vietnam Veterans have been jailed for crimes.

### **Interesting Census Stats and "Been there" Wannabees:**

1,713,823 of those who served in Vietnam were still alive as of August 1995 (census figures).

During that same Census count, the number of Americans falsely claiming to have served in-country was 9,492,958.

As of the current Census taken during August 2000, the surviving US Vietnam Veteran population estimate is: 1,002,511.

This is hard to believe, losing nearly 711,00 between 1995 and 2000. That's 390 per day.

During the Census count, the number of Americans falsely claiming to have served in-country is: 13,853,027. By this census, FOUR OUT OF FIVE WHO CLAIM TO BE Vietnam vets are not.

The Department of Defense Vietnam War Service Index officially provided by the War Library originally reported with errors that 2,709,918 US military personnel as having served in-country. Corrections and confirmations to this eroded index resulted in the addition of 358 US military personnel confirmed to have served in Vietnam but not originally listed by the Department of Defense. (All names are currently on file and accessible 24/7/365).

### **Common Myths Dispelled:**

Myth: Common Belief is that most Vietnam veterans were drafted.

Fact: 2/3 of the men who served in Vietnam were volunteers. 2/3 of the men who served in World War II were drafted. Approximately 70% of those killed in Vietnam were volunteers.

Myth: The media have reported that suicides among Vietnam veterans range from 50,00 to 100,000 - 6 to 11 times the non-Vietnam veteran population.

Fact: Mortality studies show that 9,000 is a better estimate. "The CDC Vietnam Experience Study Mortality Assessment showed that during the first 5 years after discharge, deaths from suicide were 1.7 times more likely among Vietnam veterans than non-Vietnam veterans. After that initial post-service period. Vietnam veterans were no more likely to die from suicide than non-Vietnam veterans. In fact, after the 5-year post-service period, the rate of suicides is less in the Vietnam veterans group.

Myth: Common belief is that a disproportionate number of blacks were killed in the Vietnam War.

Fact: 86% of the men who died in Vietnam were Caucasians, 12.5% were blacks, and 1.2% was other races. Sociologists Charles C. Moskos and John Sibley Butler, in their recently published book "All That W Can Be" said they analyzed the claim that blacks were used like cannon fodder during Vietnam "and can report definitely that this charge is untrue. Black fatalities amounted to 12 percent of all American killed in Southeast Asia, a figure proportional to the number of blacks in the US population at the time and slightly lower than the proportion of blacks in the Army at the close of the war."

Anyway, after all the training etc, I found myself a member of the 4th Marine Regiment, located on Guadalcanal. I did go to a promised school before going overseas. It was MOS 636, Combat Intel, and was located at Jacques Farm East of San Diego. In fact most all the schools were in the general area. Jacques Farm had the Tank School, Sniper School and a few others.

Anyway, I made the landing at an island (Emirau) that closed the noose surrounding the Island of Truk (Navy, Army, Aussies, etc were all included in the overall scheme of things.) The largest Japanese Supply Depot at that time in the Pacific Ocean. Did I mention that I was still SEVENTEEN? For what it is worth, the following is a statement made by the Camp Pendleton newspaper: "May 10, 1945" The 22nd Marines, 6th Marine Division executed a pre-dawn attack south across the ASA River Estuary and seized a bridgehead from which to continue the attack toward NAHA, the capital of Okinawa. Yeah, I was on one of those Amtrak's, an "old timer" at 19 when I joined the 22nd upon my return after the Emirau Island operation. Signed: Glenn B, Gabs, Gabby, and GB.

Ed. Note. Gabby went on to serve in Korea and eventually Viet Nam where I met him. He was an advisor to the Korean Marines there and anyone who served in Viet Nam knows of the reputation of the Korean Marines. They were Mean Mothers. His stories go on and on and many of us enjoy hearing his reminiscing.
