Terrorism and Its' Effects

Eight years ago, at approximately this time of year, our nation was attacked by terrorists. Before that time, acts like the one on September 11, 2001, were not thought about nearly as often as they are today. Every morning when I woke up, I thought about my day and what was going to occur during that day. However, it all changed for the worse when terrorists flew airplanes into The World Trade Center. All of a sudden people had to think about so much more than the average person should have to worry about. Now people have to worry if their building is big enough or important enough to be attacked. The average American's life is now just a little bit different because of the attack. Not to mention those lives that were altered far more because of the loss of a loved one. My heart goes out to those whose lives will never be the same. The changes it's had on my life are far less important.

The attacks of September 11th altered my life in small, yet important ways. I have a girlfriend in Florida, and because of the attacks, flying has become stressful when it's time for me to make the trip. I now have to get to the airport two hours early because should something not go correctly for me or another traveler I could be late. When I go, I have to be very careful what put in my carry-on bag because the last thing I need is to have a problem when trying to pass through security.

Something as simple as a letter opener could be seized from my possession and would likely draw attention and questioning. It could be seen as a weapon or sharp object that I planned on using to overtake a plane. Something like that really shouldn't have to be an issue.

On another note, I'll discuss



another affect that terrorism has had. For example, my family hunts and we used to be farmers. A common and useful tool was always a pocketknife. The attacks of September 11th are believed to have been done with small knives. Now, when a person may be in a bigger building, or definitely if you were to accidentally carry your pocketknife onto a school property or

maybe even a church, people would become uneasy. In the case of a school, you might even receive a fine. With the lack of trust between unfamiliar people as a whole, society becomes more on edge. As a result, people are given the benefit of the doubt, less and less. All this distrust and uneasiness is due largely to terrorism and it is making people think that an attack could come from any person who is in the wrong frame of mind at any time. I am proud to say that our country is working hard to lessen terrorism and trying to make its' citizens feel safer.

Some people might say the troops in the Middle East are a waste and that we will never accomplish our ultimate goal. Well, those people may very well be right to say that we will never end terrorism completely. However, is it not a good idea to give a deterrent or to eliminate potential threats prior to them accomplishing terrorist acts? It is my opinion, that every potential terrorist attack that is stopped makes it all worth the effort and even the money. Innocent lives are precious and should be kept safe. THE MARINE CORPS LEAGUE MENTORING PROGRAM!!!!

The Mentoring Program was devised so that All Detachments and Units can incorporate it into their ongoing Recruiting and Retention efforts.... It is cost free and it works! The following steps are easy to follow and in a short time you should see measured results.

- 1. Create a strong bond between the OLD and the NEW.**
- 2. Develop in new members a feeling that they too are a part of the Unit.**
- 3. Encourage and increase open communication among the members.**
- 4. The member that brings a new member into the Unit should be that Members "Mentor" until the new member feels comfortable.**
- 5. The Detachment Commandant shall assign the duties to the Junior Vice Commandant to administer this program and keep close watch on the Progress of the program.**

ALL MEMBERS SHOULD TAKE PART IN THE MENTORING PROCESS.

DO NOT FORGET THE MEMBERS THAT ARE INCAPACITATED FOR ONE REASON OR ANOTHER...SHOW THEM THAT THEY ARE STILL PART OF THE UNIT THE MENTORING PROGRAM FOR THE MCL

Among the basic tasks of every Detachment in the Marine Corps League is Recruitment and Induction of new members. The purpose is to promote growth of the League and its subsidiary units.. Only in this manner can the organization prosper.

Until recently, the league struggled to increase its overall members on a sustainable track. We lost members as fast as they were sworn in. There were and are reasons for this. A number of our Marines passed on, some became less active due to health or medical issues, and many left because of inactivity within their detachments.

These are all viable reasons, but they can all be countered with good reasons

why the membership should and could sustain their numbers even with the scenarios suggested above. We lose more members for one reason and one reason only. "They don't feel included in the social fiber or culture of the detachment." I receive letters and e-mails on a daily basis voicing these same concerns. This is where the "Mentoring Program" enters into the equation.

If you examine this closely you will find two major concerns... First is the "Fading Away" of many older members. The second is the loss of new members. Both situations must be addressed. Following are suggestions aimed at improving the "communication gap" we seem to have.

The fact that we are vigorously building a detachment we can be proud of should stimulate greater interest among area Marines to want to belong. This is good! In order to build upon this renewed interest it is proposed here that the detachment develop a "Proactive Approach" to the induction of its new members and in an effort to reach out to our members who are either temporarily or chronically unable to take an active role in the detachments programs.

In an effort to grease the wheels, so to speak, it is proposed that the detachment initiate the "Mentoring Program" that will match up "Old Salts" with our new recruits as a way to ease them into foil membership in the detachment. At the same time, it is also proposed that we initiate programs within the detachment to reach out to our brother and sister Marines whose ability to get around is restricted.

GOALS

- A. Create a bond between old and new members so new members will feel more accepted into the mainstream of the detachment.*
- B. Develop in new members a stronger feeling that they, too, are part of the team that is your detachment.*
- C. Increase the retention rate and active participation of old and new members in the activities of the detachment*
- D. Encourage and increase open communication among the membership.*

PROGRAMS

A Mentoring Program for the induction and integration of new regular and associate members into a detachment.

- 1. All prospective Regular members of the detachment shall be assigned a*

"Mentor" prior to their induction. All prospective Associates should be assigned two "Mentors."

2. Once the inductee has been accepted and sworn into the Detachment, his or her sponsor should immediately assume an active role in assisting the new member in his or her introduction into the formal and informal programs of the Detachment

3. If possible, the sponsor of the new member should be the Mentor. No member shall be required to mentor more than two new members at a time.

4. If at all possible, the mentor and new member should live in a relatively close proximity geographically.

5. The mentor relationship should continue until the new Member feels it is no longer needed.

6. The Mentoring Program shall fall under the jurisdiction of the Junior Vice Commandant.

HOMEBOUND BUDDY PROGRAM

Along with the Mentoring Program, we need to develop a system for maintaining contact with Marines whom, for a myriad of reasons, are having difficulty getting to detachment meeting and other functions. These men and women probably started the detachment and kept it operating through some difficult times. They now find themselves unable to keep up the pace and are in danger of falling out of the ranks. Many of them have begun to lose contact with the league and even the community at large.

Marines have a long history of taking care of their own. However, we sometimes lose contact with our old friends and shipmates. That should not be allowed to happen. Unless we take positive action to prevent it, we shall soon lose an important part of our history.

In that light, I propose that the detachment and the auxiliary, under the direction of the detachment chaplain initiate a program to organize volunteers responsible for maintaining contact with fellow Marines and Auxiliary members who-because of age or infirmity-can no longer be as active as they once were.

The volunteers would make regular contact by telephone or e-mail or any other means of communication available. The goal is to improve our lines of communication and regenerate the process of inclusion.

On September 19th John Fleischman ran a one man brat fry for most of the day at Piggly Wiggly in West Bend. John's determination to help the Detachment raise money shows his true esprit de corps. Although there were a couple



Members that stopped by during the event it was for the most part a one man show. Ooh-Rah John! Thank You for the **Outstanding** effort!

This is to honor my son, a Staff Sgt. of Marines. He died this August of a heart attack at the age of 34. The Medical Examiner said his heart was either damaged by the ambush or he picked up a virus that settled in his heart and the V.A. dropped the ball, in treating him. He left a family, Wife and 3 boys ages 3, 5, and 8. The following story is true, and all he got for the action was a Purple Heart. I just read a story in the Jacksonville newspaper of a Navy Submarine Officer that got a bronze star for doing a good job running electronics that blocked remote detonations of IED's. He didn't get blown up, shot at, or pull injured from the line of fire, but he got a medal. (story continues below...)

SSgt A.W. Breen Ambushed

SSgt Breen was stationed in Afghanistan during 2007, at an outpost with 2 other Marines and in charge of training about 50 Afghan troops and collecting intelligence.

During the spring of 07, they received information on a small Taliban training camp. They set out to attack this training camp in a convoy of 2 Humvees and several trucks. They had to travel up into the mountains on some very rough and narrow roads. As they got into the mountains, the road wound its way up the side of a canyon. The road was way up a cliff, with a sheer drop off on the left, and the cliff extended up and actually overhanging the road on the right side.

As they came to this one section of the road it made a big turn to the left, making an open 'U' that they were on, and the mountain across from them was a steep, sloping, bolder strewn hill across from the road. S.Sgt. Breen radioed to the other vehicles in his convoy that this was the perfect place for an ambush, and if an RPG (Rocket Propelled Grenade) came in, to hit the gas, and don't stop for at least a mile. SSgt Breen was in the turret of the 4th vehicle, a Humvee. He was manning an M-60 Machine Gun.

Once they were all in the 'U', the Taliban ambush opened up on them. An RPG hit the first truck, and two or three hit the last vehicle, another Humvee. The Afghan troops all stopped and got out of the trucks, and most of

them just ran back down the road.

It turns out that they had been set-up by an Afghan member of the Taliban, that had joined the Afghan army and was an officer. He got sick the morning of their raid, and just couldn't make the trip. He was later found out, and killed by the Afghan Army.

The ambush was one of the worst fights that year in Afghanistan. There were over 200 Taliban fighters ambushing about 50 of SSgt Breen's Afghan troops.

SSgt Breen started firing the M-60 Machine Gun, and was doing so for a couple of minutes, suddenly it stopped working. Looking down at it SSgt Breen saw that it had taken an armor piercing round right in the action, making it useless. He tossed it aside and reached down into the Humvee, and grabbed his SAW (A Hand held Machine Gun) and started firing it. During this time period, his Humvee was hit by at least three RPG's, and his turret was taking lots of hits from the Taliban.

SSgt Breen was firing the SAW, when an armor piercing round hit him in the chest, slamming him back against the turret of the Humvee. His body armor ceramic plate stopped the bullet. SSgt Breen kept firing his SAW, until it suddenly quit. It had taken an armor piercing round directly in the bolt, making it useless. SSgt Breen tossed it down, and drew his 9 MM service pistol and was shooting it at the Taliban, when he was hit in the hand, destroying the pistol, and knocking it out of his hand. The armor piercing round had gone through his right hand.

Again, during this time, his Humvee was hit by another three or four RPG's, wounding SSgt Breen in the face, neck, and arms with shrapnel.

SSgt Breen jumped out into the line of fire and picked up one of the Afghan troops big H&K machine gun, and was firing it single handed with his left hand.

He then, with his wounded right hand, grabbed a wounded Afghan soldier, and dragged him back behind the Humvee. SSgt Breen then went back out into the line of fire and grabbed another wounded troop, and SSgt Breen was again hit in the chest with another armor piercing round, and almost knocked down, but again his body armor stopped the bullet.

SSgt Breen dragged three or four more wounded troops behind the Humvee, and being a combat EMT, he administered first aid to all of them, saving their lives.

At some point during this, SSgt Breen also got on the radio and called in the Marine Cobra Helicopters that came in and saved them.

We know of SSgt Breen's actions because a short time later they captured a video tape from the Taliban. The Taliban Snipers get paid for each enemy they kill, and a big bonus for killing a U.S. Marine. The Sniper that was targeting SSgt Breen had a video being shot for him during this battle. The person running the video said something to the affect "He cannot be killed, he must be a God. Turn your gun on the others, and don't waste your bullets on him."

S.Sgt. Breen was medivacked to a field hospital, and then on back to the USA.

S.Sgt. Breen's Captain later called him and told him that they stopped counting at 70 entry holes where armor piercing rounds had gone into the Turret, and that there were at least another 30 or 40 entry holes in the Turret alone. The Humvee was hit at least 5 or 7 times by RPG's, and totally destroyed.

An Army Major who later saw the Taliban video said that "That Marine should have been put in for a Silver Star Medal. Hell, that is the stuff they make movies about!"

Dept Of Wisconsin Fall Conference:

Marines and Corpsmen

I attended the Dept of Wisconsin State Fall Conference in King on Oct 3rd.

Several key points were brought up in discussion.

Marine Corps League National HQ will be getting caught up to the 21st century and will be doing almost all correspondence via the web within the next year. This will include membership reports, transmittals, and new membership applications.

Although individual Detachments will still have to verify the applicants DD214 before being accepted.

There will be growing pains with this as there is with any large scale overhaul, but when finished it should make things go more smoothly and efficiently. The hope is that membership will grow as many young Marines do not even have checkbooks anymore, and are more willing to pay with a credit card online from the comfort of their home. Again though it will be the Detachments that will need to verify the application requirements. Speaking of which.....

The Application for Membership will soon be changing. Convicted felons or those that have been convicted for molesting children, or have been incarcerated for two or more years will not be allowed to join the MCL. Details are still being worked out with what to do about current members that will be affected by this change.

As stated several times at our own meetings, a Detachment does not survive solely by its numbers of paid members; it survives by its number of members willing to participate. VA Secretary Establishes ALS as a Presumptive Compensable Illness Cites Association between Military Service and Later Development of ALS

WASHINGTON - Veterans with amyotrophic lateral sclerosis (ALS) may receive badly-needed support for themselves and their families after the Department of Veterans Affairs (VA) announced that ALS will become a presumptively compensable illness for all veterans with 90 days or more of continuously active service in the military.

"Veterans are developing ALS in rates higher than the general population, and it was appropriate to take action," Secretary of Veterans Affairs Dr. James B. Peake said.

Secretary Peake based his decision primarily on a November 2006 report by the National Academy of Sciences' Institute of Medicine (IOM) on the association between active-duty service and ALS.

"We are extremely grateful to Secretary Peake, Congressman Henry Brown and Senator Lindsey Graham for standing on the side of veterans with ALS across the country," said Gary Leo, president and CEO of The ALS Association. "Thanks to their leadership, veterans with ALS will receive the benefits and care they need, when they need them. Thanks to their efforts, no veteran with ALS will ever be left behind."

The report, titled Amyotrophic Lateral Sclerosis in Veterans: Review of the Scientific Literature, analyzed numerous previous studies on the issue and concluded that "there is limited and suggestive evidence of an association between military service and later development of ALS."

"ALS is a disease that progresses rapidly, once it is diagnosed," the Secretary explained. "There simply isn't time to develop the evidence needed to support compensation claims before many veterans become seriously ill. My decision will make those claims much easier to process, and for them and their families to receive the compensation they have earned through their service to our nation."

ALS, also called Lou Gehrig's disease, is a neuromuscular disease that affects about 20,000 to 30,000 people of all races and ethnicities in the United States, is often relentlessly progressive, and is almost always fatal. ALS causes degeneration of nerve cells in the brain and spinal cord that leads to muscle weakness, muscle atrophy, and spontaneous muscle activity. Currently, the cause of ALS is unknown, and there is no effective treatment. The new interim final regulation applies to all applications for benefits received by VA on or after September 23, 2008, or that are pending before VA, the United States Court of Appeals for Veterans Claims, or the United States Court of Appeals for the Federal Circuit on that date.

VA will work to identify and contact veterans with ALS, including those whose claims for ALS were previously denied, through direct mailings and other outreach programs.
