**Reading of the Minutes**

Paul Bollmann made a motion to accept the Minutes from the August Meeting as posted in the September Newsletter. John Fleischman seconded the motion. Motion passed.

**Paymaster's Report**

The Paymaster distributed the monthly Financial Report and reviewed it with the Members, including a check for Ken Unertl (for the flag box), and Dan Coulter (for postage sending out solicitations for the Marine Reserve Forces Band, which netted the Detachment \$350.00). **Fundraising:** George Wujcik thanked Jim Ramage, Carl Heiman, and John Fleischman for their participation during the Sept 1 fundraiser at Walmart. The Jr Vice said that the 2007 fundraising season is over, and that the Commandant is looking for a Member to take on the position of Fundraising Chairman for next year. If interested contact John Stern.

**Newsletter:** Members not receiving their Newsletters should contact the Det. Adjutant to make sure their mailing address is correct. The Editor said that Newsletter input should be submitted to him by the first Monday of the month. Dan Coulter asked if there are extra copies of the Newsletter available to be mailed out to perspective new Members. Jim Krudwig said that, to keep costs

reasonable, there are a limited number of copies printed every month and when advised by the Membership Chair, any remaining copies are sent to prospective Members. **Birthday Ball:** Dan Coulter stated that the KetMorDet Birthday Ball is scheduled for Nov 10th this year. Several active duty and Reserve Marines have been contacted to be the guest speaker without much luck. Finding a guest speaker is a little harder this year as this is the same date as most of the other Birthday Balls around the area. Dan Coulter suggested that the Commandant speak briefly in place of a guest speaker. Jim Krudwig noted that a guest speaker is part of the Birthday Ball tradition and there are a number of retired and former Marines in the area who might be available to speak of their experiences in the Corps. Ted Conde stated that The Birthday Ball will be held at the Old Courthouse in West Bend as it was last year. Dan Coulter stated that he would like to raise the amount that the Detachment would cover for the Ball from \$500 to \$1,000. Several Members inquired as to why the amount should be raised. Dan suggested it would help lower the cost to the Members attending. It was pointed out that some of the Members attending last year's Ball were willing to pay more per person as having the Ball was worth it. The Jr Vice Commandant said that he would pass these thoughts onto the Commandant and that it would be brought before the Members again next month. Jim Krudwig made a motion to hold the Birthday Ball in November in lieu of a regular monthly Meeting. Seconded by Ken Unertl. Motion passed. There will be no general monthly Meeting in Nov. If an emergency arises, Members are asked to contact the Commandant.

#### **Old Business**

The Adjutant stated he has attempted to contact Members that are "on the bubble" for dues. Richard Schlice is currently in the hospital, and Ken Heinecke has moved with no forwarding address. The Adjutant was asked at the August Meeting to determine what info is available about a new Detachment forming in our area (Ozaukee County). The Adjutant said that he has looked at the Detachment listings "on line" and called the Dept of Wisconsin MCL Commandant several times, but has not been able to find out any info. He will try again and report back next month. Dan Coulter gave a quick recap of the Allenton Parade, and that everyone thought the Marine Band was a huge success. John Fleischman inquired as to the possibility of having them perform every year. Dan Coulter stated that it normally takes years of preparation in getting a Marine Band here. It was only by chance that the Band was in the area this year for a Change of Command ceremony that made them available. Jim Krudwig said that when he had been contacted by the Allenton Parade Committee to see if a Marine Band was available for the parade, he had made phone calls and it had taken less than six months to set it up. He noted that other than financial support no one from KetMorDet was willing to step forward and handle any of the planning for a concert in West Bend. If a Det. Member was willing to put forth a serious effort and chair a Band Committee and bring forth a game plan to the Det. Officers, then the Marine Forces Reserve Band Drum Major had told Jim that a band could probably be brought up to Wisconsin each summer, BUT NOT ON MAJOR HOLIDAYS. Other Dept of WI MCL Detachments have expressed an interest in the Marine Forces Reserve Band returning to the area. This could be looked at in the future if there is serious support beyond verbalizing how great it would be. John Fleischman stated he is interested in doing this. Paul Bollmann said that the Detachment Picnic has been put off until next year when it can be planned in a timelier manner, instead of being rushed together. He is currently looking at an early May timeframe for the 2008 picnic. The Adjutant thanked Paul for all the work he put into assembling a "business plan" for the picnic and presenting it to the Officers in preparation for bringing it before the Detachment. The Det. Judge Advocate has sent a registered letter to the National Judge Advocate regarding the use of the campaign covers and is awaiting a response. Members are reminded that before making MOTIONS to spend Detachment funds on other than charitable causes, that a "business plan" must be brought before the Officers during the Officer Call so that the details can be hashed out before bringing it before the general Membership. This will save time during meetings.

#### **New Business**

Dan Coulter asked if there are any provisions to help out with ill Members and dues. There is none. Dan Coulter asked the Officers discuss this and see if a policy of some sort could be made to help out ill Members with their dues. Jim Krudwig noted that several MCL Detachments have a policy of imposing a fee of \$1 for Marines that arrive late to the Meeting, cell phones that ring during the meeting, or cussing during the Meeting. He asked that the Officers consider something such as this so to cut down on distractions during the Meeting. Dan O'Toole noted that some all-weather gear is needed for the Color Guard as was evident during the Allenton Parade. This will be discussed at a future Meeting.

#### **Good of the League**

The Detachment wished best regards to Chris and Andrew Moericke as they leave for deployment to 29 Palms and then to Iraq with the Mad Ghosts of Fox Co. 2nd Bn 24th Marines. Jim Krudwig recently moved and thanked Fritz Montag, Don Erdman, and Jason Waier for helping him. He said that Marines helping Marines is another tradition that helps differentiate Marines from the other services. If you need help with something, don't be afraid to ask your fellow Members for support.

#### **Meeting Closed**

With no further business to be conducted, the Jr Vice Commandant gave the order to close the Meeting. The Sgt at Arms retired the Colors, the Chaplain gave the closing prayer, and the Jr Vice Commandant thanked all for attending and asked that they secure new members. The Meeting closed at 1039. The next meeting will be held at 0900 on October 20, 2007 at the Trenton Town Hall.

## MARINE CORPS SLOGAN TAKES OUT THE COMPETITION

The Marine Corps' legendary recruiting pitch, "The Few, The Proud, The Marines," defeated such famous ad slogans as "Just Do It," "Have It Your Way," "Take a Bite Out of Crime" and "Think Outside the Bun" for a spot on the advertising industry's Walk of Fame in New York City.

This year's two winning slogans - the other is Southwest Airlines' "Ding! You are now free to move about the country" - were announced as part of Advertising Week 2007, an advertising industry convention in New York City. They Corps beat out a number of companies and agencies in a nationwide Internet poll for the honor, including Nike, Burger King, The National Crime Prevention Authority and Taco Bell.

The Corps and Southwest will join previous winners, such as the Texas Department of Transportation's "Don't Mess with Texas," Verizon's "Can You Hear Me now?" and Hallmark's "When You Care Enough to Send the Very Best," on the Madison Avenue Advertising Walk of Fame, which consists of a plaque on the sidewalk between 49th and 50th Streets in Manhattan.

## Cougar Mine Protected Armored Patrol



The Cougar, developed and produced by Force Protection Inc. is a multi-purpose, 12 ton mine protected armored patrol vehicle. The design uses a monocoque, bulletproof and blast-proof capsule fitted with 4 inch thick transparent armored glass, which protects the driver and crew from small arms fire, mine blasts and IED. Typical roles for the vehicle are armored, mine protected troop transport for security, stability and

peacekeeping missions, protected weapons platform, law enforcement special response vehicle, counter IED an EOD / Range Clearance vehicle. The vehicle can accommodate 10 passengers in a 4x4 configuration and 16 passengers in a 6x6 configuration. Cougar was selected to serve with the US Marine Corps as a Hardened Engineer Vehicle (HEV), to support engineer mine clearing and explosive ordnance disposal teams deployed in Iraq. As of June 2006, there are more than 130 Cougars and Buffalos in Afghanistan and Iraq.



Since their deployment to Iraq in 2003 the Cougar and Buffalo vehicles employed with explosive ordnance disposal teams and engineers units have taken about 1,000 IED hits

without a loss of life, said Wayne Phillips, a company vice president in charge of Marine Corps programs. The vehicle has proven to be superior to less

Here are some amazing photos of the Cougar in action. This is one of the new "hardened" vehicles that was hit by a 500 lb bomb (IED). The vehicle was totally destroyed, but EVERYONE IN THE VEHICLE WALKED AWAY.

Note the unusual construction of the bottom of the hardened APC. Note the bottom looks like the hull of a ship. The blast picked up the truck and turned it around! ## THE STAR-SPANGLED BANNER

**The Star-Spangled Banner** is the national anthem of the United States, with lyrics written in 1814 by Francis Scott Key. Key, a 35-year old lawyer and amateur poet, wrote them as a poem after seeing the bombardment of Fort McHenry in Baltimore, Maryland, by British ships in Chesapeake Bay during the War of 1812.

The poem, titled "Defence of Fort McHenry," was set to the tune of the popular British drinking song "The Anacreontic Song", more commonly known by its first line, "To Anacreon in Heaven," and became a well-known American patriotic song. With a range of one and a half octaves, it is known for being difficult to sing. It was recognized for official use by the Navy in 1889 and the President in 1916, and made the national anthem by a Congressional resolution of 3 March 1931 (46 Stat. 1508, codified at 36 USC 301). Although the song has four stanzas, only the first is commonly sung today, with the fourth ("O thus be it ever when free men shall stand...") added on more formal occasions.

On September 3, 1814, Key and John S. Skinner, an American prisoner-exchange agent, set sail from Baltimore aboard the sloop HMS Minden flying a flag of truce on a mission approved by U.S. President James Madison. Their objective was to secure the release of Dr. William Beanes, the elderly and popular town physician of Upper Marlboro, a friend of Key's who had been captured in his home. Beanes was accused of aiding in the arrest of British soldiers. Key and Skinner boarded the British flagship, HMS Tonnant, on September 7 and spoke with Major General Robert Ross and Admiral Alexander Cochrane over dinner, while they discussed war plans. At first, Ross and Cochrane refused to release Beanes, but relented after Key and Skinner showed them letters written by wounded British prisoners praising Beanes and other Americans for their kind treatment.

Because Key and Skinner had heard details of the plans for the attack on Baltimore, they were held captive until after the battle, first aboard HMS Surprise, and later back on HMS Minden. After the bombardment, certain British gunboats attempted to slip past the fort and effect a landing in a cove to the west of it, but they were turned away by fire from nearby Fort Covington, the city's last line of defense. During the rainy night, Key had witnessed the bombardment and observed that the fort's smaller "storm flag" continued to fly, but once the shelling had stopped, he would not know how the battle had turned out until dawn. By then, the storm flag had been lowered, and the larger flag had been raised.

Key was inspired by the American victory and the sight of the large American flag flying triumphantly above the fort. This flag, with fifteen stars and fifteen stripes, came to be known as the Star Spangled Banner Flag and is today on display in the National Museum of American History, a treasure of the Smithsonian Institution. It was restored in 1914 by Amelia Fowler, and again in 1998 as part of an ongoing conservation program.

Aboard the ship the next day, Key wrote a poem on the back of a letter he had kept in his pocket. At twilight on 16 September, he and Skinner were released in Baltimore. He finished the poem at the Indian Queen Hotel, where he was staying, and he entitled it "Defence of Fort McHenry."

Key gave the poem to his brother-in-law, Judge Joseph H. Nicholson. Nicholson saw that the words fit the popular melody "To Anacreon in Heaven", an old British drinking song from the mid-1760's, composed in London by John Stafford Smith. Nicholson took the poem to a printer in Baltimore, who anonymously printed broadside copies of it - the song's first known printing - on 17 September; of these, two known copies survive.

On 20 September, both the Baltimore Patriot and The American printed the song, with the note "Tune: Anacreon in Heaven". The song quickly became popular, with seventeen newspapers from Georgia to New Hampshire printing it. Soon after, Thomas Carr of the Carr Music Store in Baltimore published the words and music together under the title "The Star-Spangled Banner", although it was originally called "Defence of Fort McHenry." The song's popularity increased, and its first public performance took place in October, when Baltimore actor Ferdinand Durang sang it at Captain McCauley's tavern.

The song gained popularity throughout the nineteenth century and bands played it during public events, such as July 4 celebrations. On 27 July 1889, Secretary of the Navy Benjamin F. Tracy signed General Order #374, making "The Star-Spangled Banner" the official tune to be played at the raising of the flag.

In 1916, President Woodrow Wilson ordered that "The Star-Spangled Banner" be played at military and other appropriate occasions. Although the playing of the song two years later during the seventh-inning stretch of the 1918 World Series is often noted as the first instance that the anthem was played at a baseball game, evidence shows that the "Star-Spangled Banner" was performed as early as 1897 at Opening Day ceremonies in Philadelphia and then more regularly at the Polo Grounds in New York City beginning in 1898. Today, the anthem is performed before the beginning of all NBA, NHL, MLB and NFL games, as well as in the pre-race ceremonies portion of every NASCAR race.



## Modern History of The Star-Spangled Banner

In 1944 a Boston audience was so stunned and bewildered by émigré Igor Stravinsky's modernist arrangement of the piece that the police were sent to his next concert with orders that he desist from further performances on pain of being arrested for "desecration of the national anthem."

The first "pop" performance of the anthem heard by mainstream America was by Puerto Rican singer and guitarist Jose Feliciano. He shocked the crowd at Tiger Stadium in Detroit and the rest of America when he strummed a slow, bluesy rendition of the national anthem before Game Five of the 1968 World Series between Detroit and St. Louis. This rendition started contemporary "Star-Spangled Banner" controversies. The response from many in Vietnam-era America was generally negative, given that 1968 was a tumultuous year for the United States. Despite the controversy, Feliciano's performance opened the door for the countless interpretations of the "Star-Spangled Banner" we hear today.

In fact, many "interpretative" versions of the anthem are held in high regard by modern critics, such as Marvin Gay's funk-influenced performance at the 1983 NBA All-Star Game, and Whitney Houston's stirring, high-note filled rendition before Super Bowl XXV in 1991, which when released as a single charted at number 20 in 1991 and number 6 in 2001 - the only times the anthem has been on the Billboard Hot 100. Another famous instrumental interpretation is Jim Hendrix's guitar solo at the first Woodstock Festival. Incorporating sonic effects to emphasize the "rockets' red glare" and "bombs bursting in air", it became a late-1960's emblem.

### Protocol

When the song is performed in public, it is customary for American citizens to stand and face the American flag, if one is displayed, in an attitude of respectful attention. If no flag is on display, it is customary to stand and face the source of the music in the same respectful attitude of attention as if the flag were on display. People are also encouraged to remove their hats during the performance. Boy Scouts, Girl Scouts, military personnel, fire service, and law enforcement officers in uniform normally salute during the national anthem from the first note and hold the salute until the last note is played. Civilians who are citizens of the United States should salute by placing their right hand over their heart. NOTE: A recent change authorizes military personnel not in uniform and veterans to salute the flag if they desire rather than holding their hands over their hearts.

### Translations

As a result of immigration to the United States, the lyrics of the song were translated into other languages. In 1861, it was translated into German. It has since been translated into Yiddish by Jewish immigrants, French by Acadians of Louisiana and Samoan. The third verse of the anthem has also been translated into Latin.

A Spanish-language recording of the "Star-Spangled Banner" called "Nuestro Himno" was released on 28 April 2006. This was a few days before nationwide demonstrations on 1 May regarding amnesty. This recording was created as a show of support for all illegal immigrants in the United States in response to a proposed crackdown on illegal immigration. "Nuestro Himno" used the text of the Spanish-language version, translated by Francis Haffkine Snow, of the "Star-Spangled Banner" called "La Bandera de Estrellas." This version was published by the US Bureau of Education in 1919. This same translation is on the United States Department of State's website. A reproduction of the original sheet music is on the Library of Congress website. Public reaction to "Nuestro Himno" was widely divided. It drew a critical response from President George W. Bush. "I think people who want to be a citizen of this country ought to learn English and they ought to learn to sing the national anthem in English." Despite this, President Bush's administration had Spanish versions of the Anthem posted online.

### Performances

The song is notoriously difficult for nonprofessionals to sing, because its range is wide: an octave and a half. Garrison Keillor has frequently campaigned for the performance of the anthem in the original key, G major - which can, in fact be managed by most average singers without difficulty. Professional and amateur singers have been known to forget the words, which is one reason the song is so often prerecorded and lip-synced. Other times the issue is avoided by having the performer(s) play the anthem instrumentally instead of singing it. The prerecording of the anthem has become standard practice at some ballparks.

### Lyrics (first verse)

O say, can you see, by the dawn's early light,  
What so proudly we hailed at the twilight's last gleaming,  
Whose broad stripes and bright stars, through the perilous fight,  
O'er the ramparts we watched, were so gallantly streaming?  
And the rockets' red glare, the bombs bursting in air,  
Gave proof through the night that our flag was still there.  
O say, does that star spangled banner yet wave  
O'er the land of the free, and the home of the brave?
